

## **TERMS AND CONDITIONS**

The websites (the "Sites") is comprised of various web pages operated by Edsix BrainLab Private Limited having its Registered Office at Module 1, A3 – 01, 3<sup>rd</sup> Floor, A Block, Phase 2, IITM Research Park, Kanagam Road, Taramani, Chennai – 600 113. The websites are offered to you conditioned on your acceptance without modification of the terms, conditions, and notices contained herein (the "Terms"). In the event of failure to resolve the dispute through Mediation as set out above, you shall be at liberty to refer the same for arbitration by a sole arbitrator. The mediation or arbitration shall be conducted in English and the venue for the

same shall be in Chennai, India. These terms shall be governed by the laws of India. Subject to the foregoing, courts at Chennai City shall have exclusive jurisdiction. Our products are controlled and operated from Chennai, India and we make no representations that they are appropriate or available for use in other locations.

## **25. CLASS ACTION WAIVER**

Any arbitration under these Terms and Conditions will take place on an individual basis; class arbitrations and class/representative/collective actions are not permitted. THE PARTIES AGREE THAT A PARTY MAY BRING CLAIMS AGAINST THE OTHER ONLY IN EACH'S INDIVIDUAL CAPACITY, AND NOT AS A PLAINTIFF OR CLASS MEMBER IN ANY PUTATIVE CLASS, COLLECTIVE AND/ OR REPRESENTATIVE PROCEEDING, SUCH AS IN THE FORM OF A PRIVATE ATTORNEY GENERAL ACTION AGAINST THE OTHER. Further, unless both you and Edsix BrainLab agree otherwise, the arbitrator may not consolidate more than one person's claims, and may not otherwise preside over any form of a representative or class proceeding.
